

Better Business Networks – Memberships Explained 14/02/08

In Brief:

Social Member: those who attend a BBN meeting and register on the BBN Web site to receive the Newsletter.

Full members: paid membership (\$97:00 per year, per business) for businesses to be featured on the BBN Web site members directory, to promote and advertise your business. Access for your products and services to be sold through the BBN Web site and the Web sites of BBN partners.
Special networking, advertising and promotional offers and business training opportunities.

Agents license: (\$97:00 per year , per agent) for those who want to host and run meetings with the support of the BBN system that offers extensive benefits. A great lead generating avenue for your business and fantastic social networking opportunity for your business community.

The benefits:

Social Members, You qualify by first registering for the BBN e-newsletter and accepting the BBN meetings CODE. Social Members should be prepared to receive at least 1 e-mail per week and occasional additional ones for special events and promotions. All emails will be brief with a link to the appropriate page on the website.

Full Members will have retail access to all products on the BBN website and be able to contact Full Members for their services or products through the members directory. You can attend as many BBN meetings for 1 on 1 social networking without fees as you like. Social member's only obligation is to comply with the BBN meeting CODE, one aspect of which is by supporting our BBN Meeting Premises Providers with the purchase of a meal, snack or beverages at the BBN meetings.

Full members, first register as social members and then make an additional application on the website and pay a 12 month fee (\$97:00 per year, per business)-. They receive an advertising package that includes advertising on the www.betterbusinessnetworks.com & www.ifounfitonthenet.com websites. There is access to many exclusive Web site features, such as, books and published training notes and business processes and complimentary e-books.

Full Members only events will include very lucrative opportunities for networking, marketing and self promotion. Wholesale access to BBN products and sponsored products and other Full Members services.

Full members are given priority access to being on the speakers list at BBN meetings. You may purchase more than one full membership if you have more than one business to promote. The benefits are that each membership is treated separately and given full promotional and marketing benefits.

Agents license, will require becoming a full member first. From there you make application for a license for the area and type of meeting you want to start or integrate into the BBN network/system (\$97:00 per year , per agent) and go before the BBN Agents committee (a select group of your peers) for approval.

This option is for those who want to step to the next level in social networking and lead a self generating community of proactive business people with our full support.

Licensed Agents get front line options to prospect members in their area. They have access to wholesale and bulk purchasing pricing for BBN products, programs and packaged processes.

They have exclusive rights to display and market their own business products and BBN products at their meetings.

Some Agents can become a part of the BBN steering committee and are able to be a part of special inter-area promotions and marketing.

Agents are given priority invitations to be on the speaker list at other BBN meetings. Agents are invited to join the BBN speaker approval committee and they have the strongest voice towards speakers at meetings in their own areas.

Agents may own more than 1 BBN meetings license either in the one area or other areas and must make application for each one separately. Each Agency License will be treated as a full and separate license with all advertising and promotional advantages being duplicated.
